"7th INTERNATIONAL ETCHING BIENNIAL OF VALLADOLID" AWARDS 2020

One - Purpose

The Diputación Provincial de Valladolid, in collaboration of the Asociación Cultural para las Artes de Valladolid Grupo Aguafuerte, (Culture for the Arts of Valladolid Etching Group Association), announces the 7th International Etching Biennial of Valladolid with the aim of encouraging artistic creativity in the sector of chalcography.

Two - Legal framework

This announcement will be governed by the provisions of Law 38/2003 of 17 November, General Subsidies Act (LGS), in Royal Decree 887 /2006 of 21 July, which approves the General Subsidies Regulations (RGS), and by any other applicable legislation.

This announcement is made in accordance with the General Subsidies Ordinance of the Diputación Provincial de Valladolid, approved by agreement at the Plenary Session of 24 February 2006, and published in the Provincial Official Gazette (BOP) no. 54 of 6 March 2000.

Three - Publicising

The announcement of these Awards will be made public in the Valladolid BOP (by means of a extract) on the Diputación Provincial de Valladolid's website and in the National Subsidies Database (BDNS).

Four - Recipients

- 4.1 Any national and international artist may participate in this competition.
- 4.2 The winner of the first prize of the previous edition cannot participate in this Biennial.
- 4.3 Participation in this competition implies acceptance of these rules.

Five - Works of art

- 5.1 Each artist may submit a maximum of two original works that must have been produced with chalcography (using direct, indirect or additive techniques) and which may be combined with other techniques considered to be appropriate by the artist, including digital procedures. The pieces must be signed and numbered in order to confirm that it is an Original Graphic Piece.
- 5.2 Works that have been previously been submitted and have won other competitions will not be accepted.
- 5.3 The works must have been produced during 2019 or 2020.
- 5.4 The works may be printed on paper or pulp. The size of each piece of paper or pulp for each image will be a maximum of 76 cm x 112 cm and a minimum of 54 cm x 75 cm.

Six - Prizes

- 6.1 The following prizes will be awarded:
 - 1º prize, worth 5,000 Euros.
 - 2nd prize, worth 3,000 Euros.
 - 3rd prize, worth 2,000 Euros.

These amounts are taken from budget item 204.333.00.470.00 of the Provincial Council's Budget for the year 2020, meaning that the payment of the prizes is subject to the Budget coming into effect and on adequate and sufficient credit being available to cover for this expenditure.

The Jury reserves the right to award 3 runner-up prizes without a monetary reward.

- 6.2 If more than one work of art is submitted, only one of them will be awarded a prize.
- 6.3 Prizes will be subject to legally applicable taxes.
- 6.4 In order to proceed with the payment of the prizes, the beneficiaries must provide a form with their bank details completed by the corresponding bank which is available at: <http://www.diputaciondevalladolid.es/diputacion/modulo/dipva-tesoreria/pagos/>
- 6.5 The winning works will become the property of the Diputación Provincial de Valladolid.
- 6.6 The awards ceremony will be a public event on the date set by the Diputación Provincial de Valladolid. The winners will be informed in advance to make sure they can attend.

Seven - Applications and deadline

- 7.1 The applicants must send to the address andres.munoz@dipvalladolid.es the following information:
 - Participation application form, according to the example attached as Annex I to these rules.
 - Summarised CV, no longer than one A4 page (4500 words max).

- Title, technique used and dimensions of each work of art as well as the date it was made.
- At least one photograph of each work in jpg format. The digital size of each photograph must be of at least 2 MB. The caption for each photograph must include the title of the work, and the artist's name and surname.

7.2 Applications may be submitted until the end of 31 March 2020.

Eight - Jury

8.1 The President of the Diputación Provincial de Valladolid will appoint the Jury from among people renowned in the world of visual arts, ::it the proposal of the Appointed Representative for the Employment, Economic Development, Tourism and Participation Department.

The Jury members will be announced on the Diputación Provincial de Valladolid's website before shortlisting.

8.2 The Jury is responsible for the interpretation of these rules and for submitting the proposal to the competent body to make a final decision.

8.3 The Jury's decision shall be final.

Nine - Shortlisting

9.1 The Jury will shortlist before the end of April 2020 the works considered to be of greatest interest from all the works submitted.

9.2 The decision will be notified by e-mail to all participants and will be made public on the Diputación Provincial de Valladolid's website before 30 April 2020.

Ten - Sending the works of art

10.1 The selected works must be sent duly packed and in a methacrylate frame and a simple moulding to the following address no later than 15 May 2020:

10.2 The name and surname of the author as well as the title of the work(s) must be included in an envelope.

10.3 Shipping costs will be paid by the artist and the Diputación Provincial de Valladolid cannot be held responsible for any loss or damage during transport, or for any incidents that may arise from customs procedures.

10.4 The Diputación Provincial de Valladolid will take maximum care when handling the works of art sent and will take out insurance for them.

Eleven - Awarding the prizes

11.1 The Jury will propose to the President of the Diputación Provincial de Valladolid the awarding of the prizes before the end of June 2020.

11.2 The prizes will be awarded by Decree of the President of the Diputación Provincial de Valladolid.

11.3 The decision will be notified to the winners and will be made public on the Diputación Provincial de Valladolid's website.

Twelve - Exhibition and catalogue

12.1 All selected works will be included in an exhibition to be held in the Exhibition Hall of the Palacio Pimentel in the Diputación Provincial de Valladolid in June 2020.

12.2 A catalogue of the selected works will be published.

The selected artists will authorise the organisation to photograph the works and publish them in the catalogue, with the exclusive purpose of promoting the International Biennial.

12.3 Selected artists will receive a free copy of the catalogue.

Thirteen - Return of the works of art

Selected but not awarded works of art will be sent back to the participants (prepaid freight) within 30 days of the end of the exhibition.

Confidentiality in personal data protection

Both the personal data of the participants and the data of the jurors, including the image, are subject to the duty of confidentiality protected by the European Data Protection Regulation as well as by Organic Law 3/2018, of December 5, of protection of personal data and guarantee of digital rights as protected by the security measures contained in the National Security Scheme implemented in the Provincial Council of Valladolid.
